3. RECIPIENTS OR CATEGORIES OF RECIPIENTS

The personal data will be communicated, also on the basis of the purposes contained in specific areas, to subjects who will process the data as autonomous Data Controllers, or Data Processors (art. 28 GDPR) and processed by natural persons (art. 29 GDPR) who act under the authority of the Data Controller and Data Processors on the basis of specific instructions given regarding the purposes and methods of processing, for specific purposes according to the area of reference. The data will be communicated to recipients belonging to the following categories:

- Subjects who provide services for the web site and networks (including e-mail, websites and web platforms)
- Competent authorities for compliance with legal obligations and/or provisions of public bodies, upon request.

4. DATA TRANSFER TO A THIRD COUNTRY AND/OR TO INTERNATIONAL ORGANISATIONS

The data will be transferred to non-EEA countries, in particular it is specified that they will be transferred on the basis of art. 45 towards third countries international organizations for which the Commission intervened with an adequacy decision: United States of America. In fact, the Data Controller uses suppliers who adhere to the EU-US Data Privacy Framework. 5. IS THERE AN AUTOMATED PROCESS?

Personal data will be object of a manual, electronic and automated processing. Please note that no automated decision-making processes are carried out.

6. DATA SUBJECTS RIGHTS. HOW CAN YOU EXERCISE THEM?

You can exercise your rights as expressed in Artt. 15 et seq. GDPR, by contacting the Data Controller by writing privacy@danco.it or to the other contacts above mentioned. You have the right, at any time, to request access to your personal data (Art. 15), rectification (Art. 16), deletion of the same (Art. 17), restriction of processing (Art. 18). The Data Controller shall inform (Art. 19) each of the recipients to whom the personal data have been transmitted of any rectification or erasure or restriction of processing carried out. The Data Controller shall inform the data subject of these recipients if the data subject so requests. In the cases provided for, you have the right to the portability of your data (Art. 20), in which case they will be provided to you in a structured, commonly used and machine-readable format. You have the right to object (Art. 21), at any time, to the processing of your data based on legitimate interest by writing to the contact details above with the subject "objection". In the event that he/she considers that the processing of personal data carried out by the Data Controller is in breach of the provisions of Regulation (EU) 2016/679, the data subject has the right to lodge a complaint with the Supervisory Authority, in particular in the Member State where he/she normally resides or works or in the place where the alleged breach of the Regulation occurred (Garante Privacy https://www.garanteprivacy.it/), or to take appropriate legal action.
